The City has had experience with this firm for the past two years and are very satisfied with their work. Staff recommends approval.

# ORDINANCE 2000-59 - AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT TO PURCHASE WITH WILLIAM AND JUNE TRICE FOR THE ACQUISITION OF PROPERTY AT 640 SOUTH MASON MONTGOMERY ROAD, MASON, OHIO AND DECLARING AN EMERGENCY

A motion to read by title only was made by Councilmember Pelfrey, seconded by Councilmember Muennich. VOTE: 6 YEAS, 1 ABSTAIN (Davis)

Scot Lahrmer stated the City is interested in purchasing the property currently owned by William and June Trice located on Mason-Montgomery Road because it is adjacent to the property owned by the City and being developed into the new Mason High School, Recreation Center and Municipal Building. He further explained while not necessary for the development, it provides some additional opportunities for the City. The City has extended an offer to purchase the property at the appraised price of \$161,656 and the Trice's have accepted that offer.

A motion to suspend the rule was made by Councilmember Muennich, seconded by Councilmember Davis. VOTE: 6 YEAS, 1 ABSTAIN (Davis)

Motion to adopt Ordinance 2000-59 was made by Councilmember Fox, seconded by Councilmember Staten. VOTE: 6 YEAS, 1 ABSTAIN (Davis)

#### **COMMUNTIY REINVESTMENT AREA # 12 APPLICATION-DIGINEER**

Kim Coyner addressed Council and stated the firm of Digineer, Inc. has interest in locating in Mason at the Cintas Commerce Park. She explained this firm is an Internet professional services company that specializes in developing business-to-business consumer strategies and solutions for the trillion dollar healthcare industry. The company currently has 123 employees and an annual payroll of \$8.4M with an average salary of \$65,000. The growth plans for this firm include adding 150 employees over the next three years with a projected payroll increase of \$10M. The Economic Development Committee recommends that Mason City Council approve an abatement to Al Neyer, Inc. as property owner for Digineer, under the Community Reinvestment Area Program, 100% of real property improvements for a maximum of 15 years and to authorize the City Manager to enter into an agreement with Digineer to define the terms of the abatement based on performance measures related to the construction of all three phases and to projected job creation for the project. This abatement is contingent upon the annual compensation payment to the Mason City School District for the term of the abatement. Mr. Rick Eagan, the Chief Financial Officer, introduced himself to Council and stated his firm has been impressed with the pro-business environment in Mason.

A motion to grant the abatement contingent on compliance to the aforementioned conditions was made by Councilmember Davis, seconded by Councilmember Beck. VOTE: ALL YEAS

#### CITY MANAGERS REPORT

- There will be a Council work session on May 17, at 6:30 p.m. at the Mason Central location with the School Board.
- An opening ceremony will take place on May 18, 2000 for the I&O Railroad project.
- The Employee Excellence Picnic took place on May 3, 2000. Employees were recognized for their outstanding efforts. Each winner received a variety of gifts. It was suggested Council members be recognized for their years of service with anniversary pins. This could also apply to various board members.
- On Thursday, the City's network was impacted by the "I Love You" virus. Fortunately, the computer consultant was on site and within seven minutes, the network was shut down and the virus isolated. The potential of major data loss was avoided.
- Final word on the Police Department re-accreditation will occur in July. The process concluded last week and the assessors will recommend re-accreditation.

#### COUNCIL OLD AND NEW BUSINESS

It was determined an Ad Hoc Fire Committee meeting will take place in the near future.

A question was raised about a traffic light at Appaloosa and SR741. A signal is planned for Cox-Smith Road and SR741, although it has not been budgeted or programmed. Staff will stay aware of the need for this signal to be installed. It may be necessary to move up the priority on this location.

It was requested a meeting be set up with Sprint to discuss the frequent complaints the City receives from residents and businesses.

Councilmember Beck will hold a "Councilmember Chat" on May 15, 2000 at the library.

Mason was the host city of the annual Mayor's Prayer Breakfast this year. The event was very successful with approximately 220 attending.

A request for a transfer of a liquor permit for 5171 Sentinel Oak Road was discussed. A motion to not request a hearing was made by Councilmember Muennich, seconded by Councilmember Davis. VOTE: 6 YEAS, 1 ABSTAIN (Pelfrey)

A motion to add Ordinances 2000-60 and 61 to the agenda was made by Councilmember Staten, seconded by Councilmember Davis. VOTE: ALL YEAS
