ORDINANCE NO. 2001-12

ACCEPTING ANNEXATION ON APPLICATION OF THE OWNER OF CERTAIN PROPERTY CONTAINING 29.376 ACRES LOCATED IN DEERFIELD TOWNSHIP TO THE CITY OF MASON, OHIO

WHEREAS, the petition for annexation of certain territory in Deerfield Township was duly filed by Charles W. and Virginia F. Araujo, petitioners; and


