

COUNCIL WORKSESSION
MARCH 12, 2001

Mayor McCurley called the meeting to order at 6:02 p.m.

ATTENDANCE

The following members of Council were in attendance: Jim Fox, Dick Staten, Tom Muennich, Betty Davis and John McCurley.

MASON-MONTGOMERY ROAD WIDENING

David Frederick of 4946 Laurelwood Court addressed Council as the representative of the group of homeowners present. See attached list for residents' names and addresses of those in attendance. He stated their purpose was not to block the project. The desire to meet with Council was to inform them of their concerns and present their proposal of how the project would be more acceptable. The three concerns they mentioned in priority order were as follows:

1. Safety (for children and for vehicular traffic entering and leaving the street).
2. Necessity of 2 south bound lanes in a residential area.
3. Residential impacts

Mr. Frederick went on to state they have a proposal that includes three facets listed as follows:

- A. Build only 1 south bound lane.
- B. Reduce the width of the bike path from 20 to 10 feet.
- C. Provide appropriate landscaping in the residential area.

Mr. Gene Martin of TEC Engineering addressed the group and explained how the road improvement has been designed and presented details on why the number of lanes has been planned. He mentioned a few problems that having only one lane going southbound could cause. Mr. Frederick mentioned the homeowners have concerns that no improvement is planned for Route 42.

Council discussed the matter of the width of the bike-path. Mayor McCurley stated the road has been designed using projections that can accommodate future growth. He stated the Engineering Department will review their comments and concerns and report back to Council. Scot Lahmer will respond to the homeowners group.

Mayor McCurley closed the meeting at 6:57 p.m.
