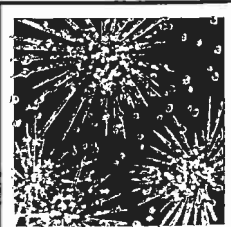


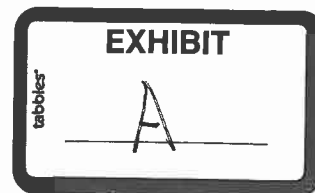

DISPLAY CONTRACT



This contract entered into this 20th day of January 2003 by and between Rozzi's Famous Fireworks, Inc and City of Mason Parks & Recreation, Mason, OH

Witnessed:

1. Rozzi's, for and in consideration of, and of the terms herein mentioned, agrees to furnish one fireworks display on July 3, 2003. Rain date to be: _____
2. City of Mason Parks & Recreation will designate and furnish to Rozzi's sufficient space for the proper giving of said displays and all such police protection for the premises as required by NFPA 1123 (code for conducting a Public Display.) Rozzi's will cooperate with reasonable requests made by City of Mason Fire Dept. in order to comply with all safety requirements.
3. Rozzi's will not be liable for damages to automobiles parked less than 1000ft from the mortars. City of Mason Parks & Recreation will notify spectators in the surrounding area by signage of the impending fallout from the fireworks that may do damage to automobiles.
4. Rozzi's agrees to furnish Public Liability and Property Damage Insurance for the fireworks display performed pursuant to this contract in the amount of a least Ten Million Dollars CSL. Rozzi's will deliver to City of Mason Parks & Recreation evidence of the required insurance coverage prior to commencement of the fireworks display pursuant to this contract.
5. Rozzi's agrees to furnish experienced operators to set up and fire the display and will be responsible for determining and implementing, or where appropriate directing City of Mason Parks & Recreation to provide, all necessary safety measures for the fireworks display. The costs of such safety measures will be borne by City of Mason Parks & Recreation.

6. Rozzi's will comply with all safety measures required by City of Mason Fire Dept. and any governmental agencies having jurisdiction thereof.

7. Rozzi's will obtain all necessary state and local permits required by law.

8. City of Mason Parks & Recreation agrees to pay Rozzi's the sum of *twenty one thousand dollars (\$ 21,000.00)* ten days after said display shall have been given.

9. City of Mason Parks & Recreation will pay the sum of (\$2100.00) in the event the show is cancelled due to rain, high winds, or inclement weather conditions. Unless otherwise specified Rozzi's will schedule a rain out on the next clear night following agreeable to both parties. A rescheduling fee will be charged in the event the show is rescheduled because of weather and has to be re assembled at a later date. The total fee charged will not exceed 10% of this contract price.

10. This contract shall not be construed to create a partnership between the parties mentioned herein.

11. In the event of fire, accidents, strikes, delays, flood act of God or other causes beyond the control of the parties, other than those specified in item 9, which prevent the performance of the fireworks display, the parties hereto release each other from any and all performance of obligations herein contained and from damages resulting from the failure to perform any such fireworks display.
