



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter the "Agreement ") is entered into between THE CITY OF MASON (hereinafter "Mason"), and GENERAL ELECTRIC CREDIT UNION (hereinafter the "Credit Union").

W I T N E S S E T H:

WHEREAS, the Credit Union is concerned for the safety of its customers and employees;
and

WHEREAS, Mason provides off duty police officers to the Credit Union on a daily basis;
and

WHEREAS, the Credit Union has routinely requested the presence of a marked police cruiser for these special-duty details; and

WHEREAS, a marked police cruiser cannot be guaranteed during the hours a City of Mason Officer is working at the Credit Union in an off duty capacity; and

WHEREAS, it is the intention of Mason Police Department to purchase at least four (4) new police cruisers in the year 2004; and

WHEREAS, the Credit Union desires to donate the sum of \$25,000.00 to the City of Mason to be used for the purchase of an additional police cruiser.

NOW, THEREFORE, in consideration of the mutual agreements, covenants and promises set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby **AGREED AND UNDERSTOOD** between Mason and the Credit Union ("the parties") as follows:

1. The Credit Union shall donate the sum of \$25,000.00 to the City of Mason on or before _____, 2004.
2. Said donation shall be in the form of an irrevocable gift to the City of Mason, thereby eliminating all rights and interest in the funds that may have been held by the Credit Union.
3. Mason shall use all reasonable efforts to purchase an additional fifth police cruiser in the year 2004.
4. Upon delivery of the new police cruisers, Mason shall give priority to the Credit Union with respect to availability of police cruisers requested for special-duty details, making all reasonable efforts to ensure that a police cruiser is available for the Credit Union.
5. The Mason Chief of Police shall have sole discretion in making a decision to remove the police cruiser from the Credit Union due to an emergency where the police cruiser is needed for the public health, safety and welfare.
6. In the event that Mason initiates a policy whereby a fee is charged for the use of police cruisers associated with special-duty details, the Credit Union shall be exempt from such fee for a term not to exceed five (5) years after the initiation of such fee policy. However, in no event shall the fee exemption extend beyond the term of this Agreement.
7. The term of this Agreement shall be for five (5) years from the date of execution. On the date of termination, this Agreement shall expire and become null and void, without notice by and from either Party.

ORDINANCE NO. 2004-11

**AUTHORIZING THE CITY MANAGER TO ENTER INTO A
CONTRACT WITH 32 FORD FOR THE PURCHASE OF ONE (1) 2004
FORD CROWN VICTORIA POLICE INTERCEPTORS**

WHEREAS, the State of Ohio has advertised and received bids for the purchase of vehicles; and

WHEREAS, 32 Ford is equal to or less than the best bidder with a price of \$21,157.00 per vehicle for the purchase of one (1) 2004 Crown Victoria Police Interceptor.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Mason, Ohio, six members elected thereto concurring:

Section 1. That the City of Mason accepts the State's vehicle specifications and agrees that 32 Ford is equal to or less than the best bidder.

Section 2. That the City Manager is hereby authorized to enter into a contract with 32 Ford for the purchase of one (1) 2004 Crown Victoria Police Interceptor for use as a police vehicle.

Section 3. That the Finance Director is hereby authorized to pay 32 Ford the sum of \$21,157.00 for said vehicle.

Section 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
