BE IT ORDAINED by the Council of the City of Mason, Ohio, six members elected thereto concurring:



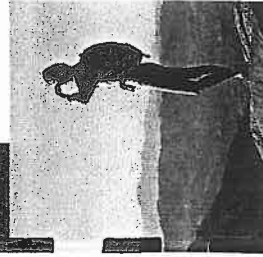
