

ORDINANCE NO. 2007- 121

**AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH THE OHIO DEPARTMENT OF TRANSPORTATION TO IMPROVE THE RIGHT TURN LANES AND SIGNAL AT THE INTERSECTION OF IR 71 RAMPS WITH WESTERN ROW ROAD AND KINGS ISLAND DRIVE**

The following Final Resolution enacted by the City of **Mason**, Ohio, hereinafter referred to as the Legislative Authority/Local Public Agency or "LPA", in the matter of the stated described project.

WHEREAS, on **27<sup>th</sup> day of September, 2004**, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

**This project consists of adding a merge lane to Kings Island Drive northbound from Western Row Road. Removing and paving an existing raised island, revising the pavement marking through the intersection and replacing the existing traffic signal, lying within the City of Mason; and**

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

**The City agrees to assume and bear ten percent (10%) of the Preliminary Engineering, Right-of-Way and Construction costs of the improvement, with ODOT assuming ninety percent (90%) using Federal-aid funds set aside by the Director of Transportation of the State of Ohio for the financing of this improvement from funds allocated by the Federal Highway Administration, U.S. Department of Transportation.**

**In addition, the City also agrees to assume and bear one hundred percent (100%) of the cost of any construction items requested by the City on the entire improvement, which are not necessary for the improvement, as determined by the State and Federal Highway Administration.**

The share of the cost of the LPA is now estimated in the amount of **Eighty One Thousand Three Hundred Forty Six and - - 00/100 Dollars, (\$81,346.00)**, but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.


NOW, THEREFORE, be it resolved:


- I. That the estimated sum of **Eighty One Thousand Three Hundred Forty Six and - - - 00/100 Dollars, (\$81,346.00)**, is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from **Federal** funds.
- II. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.
- III. That the LPA enter into a contract with the State, and that **City Manager** be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.
- IV. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.
