Eric –

Thank you for the return call. I know this is uncharted territory, at least for the past 25 years, in Mason. I am attaching my resume, which I have already sent over to Ken Schneider. I am also working on gathering letters of recommendation from people that I have work with and against in court. One of the benefits of having been the Mason assistant prosecutor within the last few months is that I could step in tomorrow and not miss a beat. I'm sure the law director or city council (whomever will be guiding the process) wants to do this right, not just quick. Having said that, I am available to be the interim prosecutor while the process progresses. I know the Judge, the court personnel, and the officers (from Mason, Deerfield and State Highway Patrol) so the prosecutor's office would not suffer despite the fact it is losing a 25 year veteran. It is that veteran and others that trained me.

In the two years I prosecuted in Mason I handled countless bench trials and motions, 14 jury trials and wrote over 10 appeals. I also argued in front of the 12th District on multiple occasions. For the last five months I have been assisting the Prosecutor in Middletown while she was on maternity leave.

Working for Robert was a wonderful experience and he was quite complimentary of my skills in Mason Court. It was on his recommendation that I moved to Middletown where the population is approximately 70,000, compared to the Mason and Deerfield population of approximately 55,000. The dockets reflect the different economics and populations with Middletown handling 19,000 criminal cases a year compared to Mason's 9,000. In addition to Mason and Middletown, I have appeared in Hamilton Municipal, Area III Court, and Warren County Court regarding criminal matters.

Multi-tasking is also essential in municipal court and I have balanced not only the docket in Mason, but the docket in Middletown, which is twice the size. Being in numerous other courts has allowed me to get ideas for areas of improvement in Mason. Having survived Judge Batche's predecessor, I believe I can handle any twist or stress that is thrown my way.
