

ORDINANCE NO. 2014 - 79

**AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH RICHARDS ELECTRIC SUPPLY CO., INC., IN AN AMOUNT NOT TO EXCEED \$34,000.00 AND DECLARING AN EMERGENCY.**

WHEREAS, proposals were requested for supplying Two Hundred and Forty (240) high bay, high output, 6 lamp fluorescent light fixtures for the Municipal Services Center; and

WHEREAS, Richards Electric Supply Co., Inc., submitted an acceptable proposal in an amount not to exceed \$34,000.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Mason, Ohio, seven members elected thereto concurring:


Section 1. That the proposal from Richards Electric Supply Co., Inc., for supplying 240 light fixtures and mounting hardware at the Municipal Services Center, in an amount not to exceed \$34,000, is hereby accepted by the City of Mason.

Section 2. That the City Manager is hereby authorized to enter into a contract with Richards Electrical Supply Co., Inc., for supplying 240 light fixtures for the Municipal Services Center, substantially in conformity with the proposal attached hereto as Exhibit "A" and incorporated herein by reference.

Section 3. That the Finance Director is hereby authorized to pay Richards Electric Supply Co., Inc., an amount not to exceed \$34,000, pursuant to the terms of the proposal.

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall be effective immediately upon its passage. The reason for said declaration of emergency is the need to keep the project on schedule.
