- 8.) North 34°06'54" East, 109.27 feet to the south line of a 50.4664 acre tract of lands conveyed to CITY OF MASON, OHIO in Warren County Document Number 2014-017335, records of the Warren County, Ohio Recorder's Office;

Thence along the south line of said 50.4664 acre tract, continuing along said corporation line, North 84°30'52" West, 1,506.15 feet to the southwest corner of said 50.4664 acre tract;

Thence along the north line of said CITY OF LEBANON lands and extension thereof, South 55°11'13" East, 80.03 feet to the south line of aforesaid US ROUTE 42 and existing corporation line of the City of Lebanon;

Thence along the south line of said US ROUTE 42 and continuing along said corporation line, the following three (3) courses and distances:

- 2.) Along an arc deflecting to the right, having a central angle of 00°47'00", a radius of 22,958.32 feet and a length of 313.88 feet. The chord of said arc bears South 33°43'24" West, 313.88 feet;
- 3.) South 34°06'54" West, 214.62 feet to a north line of the aforesaid 222.7418 acre tract of lands conveyed to TERRA FIRMA DD, LLC;

Thence along lines of said TERRA FIRMA DD, LLC lands and continuing along said corporation line, the following eight (8) courses and distances:

- 1.) South 53°52'59" East, 393.96 feet to the east line of aforesaid Section 20;
