Event Notes: Entertainer shall maintain for the duration of the contract Commercial General Liability insurance, for bodily injury and property damage, and including products-completed operations coverage, in an amount not less than \$1 million per occurrence. The City of Mason, Mason City Schools, and their respective officials, employees and volunteers are to be covered as additional insureds with respect to liability arising out of work or operations performed by or on behalf of Entertainer in conjunction with the Masons Red, Rhythm, and Boom event. For any claims under this contract, Entertainers insurance coverage shall be primary as respects the Additional Insureds. Any insurance or self-insurance maintained by the Additional Insureds shall be excess of the Entertainers insurance and shall not contribute with it. No less than five days prior to commencing activities under this agreement, Entertainer shall provide Client a certificate of insurance verifying coverage. Client reserves the right to require at any time complete certified copies of insurance policies, including amendatory endorsements, effecting coverages required herein.

SuperGames Shall Indemnify and Hold Client Harmless: SuperGames agrees to defend, indemnify, and hold Client harmless from any and all claims, actions, lawsuits, damages, liability and expense (including, but not limited to, attorneys fees and costs) arising from loss, damage, death, or injury to persons or property

occurring in, during, or arising from the performance of this agreement and the obligations incurred herein.

The contract includes:

1. All staff necessary to deliver, set-up, operate and tear down all activities (excluding running carnival games).
2. SuperGames will provide generators necessary to run all activities.
3. SuperGames staff will do a site visit in late March/ early April to discuss logistics and set-up for the event.
4. Balloon artists and face painters to perform 5 hours of work.

In kind contributions:

1. Access to activity area up to 4 hours prior and 2 hours following event.
2. Parking access for SuperGames vehicles & trailers.
3. Volunteers to run the 6 carnival games.
