

**CITY OF MASON  
COUNCIL MEETING  
JULY 11, 2016**

The meeting was called to order at 7:00 p.m. Father Eric Roush opened the meeting in prayer. All those present recited the Pledge of Allegiance.

**ATTENDANCE**

**APPROVAL OF MINUTES**

A motion to approve the June 13, 2016 Council Meeting Minutes was made by Councilmember Chance, seconded by Vice Mayor Spaeth. VOTE: ALL YEAS.

A motion to approve the June 20, 2016 Special Council Meeting Minutes was made by Councilmember Prince, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

**CITY MANAGER'S REPORT**

Eric introduced and welcomed Jillian Brandstetter of Wood & Lamping, filling in for Jeff Forbes at tonight's Council meeting.

With approximately 300 people in attendance, the 2016 Sunshine Concert Series kicked off on Sunday, July 10 at Mason Municipal Center, combined with Mason Historical Society's Ice Cream Social. The next concert on July 17, partnered with the Mason Deerfield Chamber of Commerce, will be held at Mason's Downtown Plaza from 6:00 to 9:00 p.m. The Jay Jesse Johnson Band (Blues Band) will perform throughout the event which in addition to the concert will include inflatables, food vendors, and other organizations and businesses participating.

On July 17, the City of Mason will host Women's, Men's, and Kid's events at the Mason TRI-Umphant Triathlon. Events begin with a swim in the Lou Eves Municipal Pool, a 20K bike through the streets of Mason, and ends with a 5K run through Pine Hill Lakes Park and Corwin M. Nixon Park. Proceeds from this popular event benefit Mason Parks and Recreation Foundation Common Ground.

Meet at the Golf Center to enjoy a tour of Mason Parks. The trolley tour will take place on Sunday, July 31 from 4:30 p.m. to 5:30 p.m. After the tour, participants will receive a coupon valid for a free dinner basket to enjoy while listening to the Sunshine Concert beginning at 6:00 at the Golf Center.

Premier members of the Community Center are invited to the Lou Eves Municipal Pool on August 5 for swimming, games, prizes and food provided by Comet's Pizza.

A Red, Rhythm and Boom debrief meeting will be held next week, which will summarize data and results from the event, including total dollars raised for Common Ground. Numerous compliments have been received regarding the event and appreciation to City Council, staff, neighbors, and sponsors for a successful event. This regional event is expected to grow in the future. Staff is currently working on implementing plans for the upcoming local event, Heritage Festival on September 17, in combination with the Patriot Fair.

A motion to not request a hearing for a D2 liquor permit for Fuku Asian Bistro, Inc. at 5490 Beach Boulevard was made by Vice Mayor Spaeth, seconded by Councilmember Nelson. VOTE: ALL YEAS.

### **COMMITTEE REPORTS**

Councilmember Pelfrey stated Safety Committee discussed three options to repair Mason-Montgomery Bridge. After consideration, the Committee's recommendation is to take down the center wall and place sizable planters to provide some barrier for pedestrians using the bridge.

Councilmember Prince stated he sent an email to Mason Police Department, individually thanking them for what they do. We enjoy a wonderful, safe environment in Mason. He encourages Council members and Mason citizens to communicate thanks and support to our Police Officers.

Councilmember Chance asked for continued prayers for Ginny Sundin, Park Board President, who fell in early June and is now slowly recovering at the Drake Center. Ginny's 89<sup>th</sup> birthday is tomorrow, July 12.

### **RECOGNITION OF VISITORS** - none

### **ORDINANCE 2016-69 AMEND THE CODE OF ORDINANCES OF THE CITY OF MASON TO AMEND IN PART ZONING CODE CHAPTERS 1133 AND 1188 (ZONING CODE AMENDMENTS)**

A motion to read by title only was made by Vice Mayor Spaeth, seconded by Councilmember Prince. VOTE: ALL YEAS.

Eric Hansen explained that a first reading of this ordinance was on May 16 with a public hearing on June 13. At the June meeting, Council tabled Ordinance 2016-69 to allow additional time to absorb information presented. Kurt Seiler introduced Paul Nichols of PBM Wireless to answer technical questions related to the field. Additional information was gathered during Council discussion. Towers placed in the right-of-way are not specific to any one carrier and no leasing fee is collected. Eric stated towers not in the right-of-way generally collect some sort of leasing fee. Micro cell towers are placed 2,000 feet apart and multiple carriers can be located on one tower. Kurt stated a site plan application fee of \$200 would be collected and would come before Planning Commission for approval. A request to locate a tower between two existing towers would be required to demonstrate a specific need and obsolete towers would be removed within six months. Currently, approval for large cell towers only come before Planning Commission

and the approval process for small cell towers is proposed to be the same. Council expressed interest in requiring Council approval for each request. Kurt confirmed proposed legislation does not allow location of small cell towers in the right-of-way of local residential streets and arterial/collector streets have a set-back requirement that would need to be met before installing towers in the right-of-way. Current City of Mason regulations do not allow small cell towers in the right-of-way and Council discussed possible advantages of locating small cell towers closer to buildings in need of additional bandwidth or signal strength, on private property, rather than in the right-of-way. Council discussed if there is a real need for additional cell phone coverage in the City of Mason. The City has not received requests for better coverage, other than from wireless carriers, the phone industry is driving the need. Paul Nichols stated 300 micro towers have been installed in the greater Cincinnati area with a goal to install 400 in total. Coverage will get worse in the future if we depend on an infrastructure that becomes obsolete in service delivery and micro cell towers allow easy installation of technology upgrades. Paul stated that radiation exposure from small cell towers is regulated by the FCC and that there is no known health risk associated with them. Council suggested contacting Mason schools and businesses to solicit their input on this topic.

A motion to table Ordinance 2016-69 to the September 12, 2016 Council meeting was made by Councilmember Pelfrey, seconded by Councilmember Prince. VOTE: ALL YEAS.

**ORDINANCE 2016-79 AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH OHMER CONTRACTING, INC., IN THE AMOUNT OF \$23,500, FOR THE REMOVAL OF THE CENTER BARRIER WALL AND PROVIDING A CONCRETE CURB IN PLACE OF THE WALL ON THE MASON-MONTGOMERY BRIDGE OVER THE MUDDY CREEK AND DECLARING AN EMERGENCY**

A motion to read by title only was made by Councilmember Chance, seconded by Councilmember Grossmann. VOTE: ALL YEAS.

Eric Hansen explained this ordinance was tabled at the June 13 Council meeting to allow Safety Committee the opportunity to consider options regarding removal or repair of the center wall on the Mason-Montgomery Road Bridge. Safety Committee recommends removing the wall, extending some concrete, and installing large decorative planters. This recommendation reduces maintenance, preserves aesthetics, and provides some safety features. No change to legislation is required with this recommendation. Estimated cost of the planters is \$12,000 with yearly maintenance of \$5,000 and will likely not require additional legislation. Safety Committee recommends adoption of the next four ordinances and Eric recommends the addition of an emergency clause to each, so this project can be completed within the season and to minimize disruption of bridge access.

A motion to add an emergency clause to Ordinance 2016-79, Ordinance 2016-80, Ordinance 2016-81, and Ordinance 2016-82, was made by Councilmember Prince, seconded by Councilmember Chance. VOTE: ALL YEAS.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Prince, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-79 as amended was made by Councilmember Grossmann, seconded by Councilmember Prince. VOTE: ALL YEAS.

**ORDINANCE 2016-80 AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH BRICK TEC, INC., IN THE AMOUNT OF \$54,862.82, FOR THE REPLACEMENT OF CAPS AND CULTURED STONE ON MASON-MONTGOMERY BRIDGE BARRIER WALLS AND DECLARING AN EMERGENCY**

A motion to read by title only was made by Vice Mayor Spaeth, seconded by Councilmember Grossmann. VOTE: ALL YEAS.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Nelson, seconded by Councilmember Prince. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-80 as amended was made by Councilmember Prince, seconded by Councilmember Chance. VOTE: ALL YEAS.

**ORDINANCE 2016-81 AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH ALLIED FENCE BUILDERS INC., IN THE AMOUNT OF \$12,625, TO INSTALL NEW FENCE ON THE BARRIER WALLS ON THE MASON-MONTGOMERY BRIDGE OVER MUDDY CREEK AND DECLARING AN EMERGENCY**

A motion to read by title only was made by Councilmember Nelson, seconded by Councilmember Chance. VOTE: ALL YEAS.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Grossmann, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-81 as amended was made by Councilmember Prince, seconded by Councilmember Chance. VOTE: ALL YEAS.

**ORDINANCE 2016-82 AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH AMERICAN FACADE RESTORATION, LLC, IN THE AMOUNT OF \$24,535, TO CAULK, CLEAN AND SEAL THE BARRIER WALLS ON THE MASON-MONTGOMERY BRIDGE OVER MUDDY CREEK AND THE DOWNTOWN PLAZA WALLS AND DECLARING AN EMERGENCY**

A motion to read by title only was made by Councilmember Prince, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Nelson, seconded by Councilmember Chance. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-82 as amended was made by Vice Mayor Spaeth, seconded by Councilmember Prince. VOTE: ALL YEAS.

**ORDINANCE 2016-86 APPROVAL OF THE REPLAT OF LOTS 8 & 9 OF CROOKED TREE PRESERVE SUBDIVISION PHASE 1A**

A motion to read by title only was made by Vice Mayor Spaeth, seconded by Councilmember Prince. VOTE: ALL YEAS.

Kurt Seiler explained the replat of lots 8 & 9 in the Crooked Tree Preserve subdivision, Phase 1A, will slightly adjust the property line between two lots to help with alignment of the driveway for lot 9. Planning Commission recommends approval of Ordinance 2016-86.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Grossmann, seconded by Councilmember Prince. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-86 was made by Vice Mayor Spaeth, seconded by Councilmember Chance. VOTE: ALL YEAS.

**ORDINANCE 2016-87 APPROVAL OF THE FINAL PLAT FOR CROOKED TREE PRESERVE SUBDIVISION PHASE 1B**

A motion to read by title only was made by Councilmember Chance, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

Kurt Seiler explained Crooked Tree Preserve, Phase 1B is the second phase of Crooked Tree Preserves subdivision on the former Crooked Tree Golf Course. It is currently under construction and is located just south of Phase 1A off Sentinel Oak Drive, between Sycamore View Drive and Birch View Drive. He said the 22-acre phase, zoned R-3 Single-Family Residential, will contain 23 single-family lots and two open space lots. Planning Commission recommended approval of the final plat contingent upon the completion of the roads and bridge construction and submittal of the performance bond and subdivider's contract. The plat will not be released for recording until construction is complete, which is expected to be in the next two weeks.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Chance, seconded by Councilmember Grossmann. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-87 was made by Councilmember Pelfrey, seconded by Councilmember Prince. VOTE: ALL YEAS.

**ORDINANCE 2016-88 AUTHORIZING CONTINUED PARTICIPATION IN THE AMENDED AND RESTATED WARREN COUNTY DRUG TASK FORCE COUNCIL OF GOVERNMENTS CONTRACT**

A motion to read by title only was made by Councilmember Chance, seconded by Councilmember Grossmann. VOTE: ALL YEAS.

Eric Hansen stated the City of Mason is a charter member of the Warren County Drug Task Force, formed in 1991, and has remained very active since that time. The task force is funded by a combination of funds, including grants and membership fees from each political subdivision. Council approved Ordinance 2016-13 authorizing the City's contribution, in the amount of \$30,712 towards continued participation in the Drug Task Force. Eric explained Warren County would like to update Drug Task Force agreements to reflect expanded membership, which includes most jurisdictions in Warren County.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Nelson, seconded by Councilmember Grossmann. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-88 was made by Councilmember Chance, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

**ORDINANCE 2016-89 AUTHORIZING THE CITY MANAGER TO REIMBURSE MASON CITY SCHOOLS IN AN AMOUNT NOT TO EXCEED \$40,000 RELATED TO THE PURCHASE OF A VIDEO SCOREBOARD FOR THE COMPETITION POOL**

A motion to read by title only was made by Councilmember Grossmann, seconded by Councilmember Prince. VOTE: ALL YEAS.

Eric Hansen stated the current scoreboard in the competition pool, a shared area with Mason City Schools, is aging and needs to be replaced. Replacement parts are becoming obsolete which makes repairs difficult to complete. He explained that a new full color video scoreboard, with digital technology, offers additional programming and sponsorship opportunities. The scoreboard would be a shared asset, including shared advertising revenues, between the City and Mason City Schools. Mason City Schools will purchase and install the scoreboard and the City will reimburse the Schools for its share of the cost, not-to-exceed \$40,000. The total estimated expense for the new video scoreboard is not-to-exceed \$80,000.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Grossmann, seconded by Councilmember Chance. VOTE: ALL YEAS.

During Council discussion, questions were raised regarding expense, lifespan, and the effect humidity will have on the scoreboard. Eric explained that school staff has been responsible for selecting the scoreboard and he expects that the decision has been well vetted. He added revenue generated from this scoreboard may drive any decisions for future upgrades. Councilmember Nelson asked what will be done with the old scoreboard. Eric explained that unlike the new scoreboard, which is a shared asset, the old scoreboard is owned by Mason City Schools. It was purchased over 13 years ago and is their decision as to what to do with it.

A motion to adopt Ordinance 2016-89 was made by Councilmember Prince, seconded by Councilmember Nelson. VOTE: ALL YEAS.

**ORDINANCE 2016-90 AUTHORIZING REIMBURSEMENT TO THE WARREN COUNTY COMMISSIONERS IN AN AMOUNT NOT TO EXCEED \$178,888 FOR THE BETHANY ROAD #59-2.47 BRIDGE REPLACEMENT PROJECT**

A motion to read by title only was made by Councilmember Prince, seconded by Vice Mayor Spaeth. VOTE: ALL YEAS.

Kurt Seiler stated the City and County were successful in obtaining a joint Ohio Public Works Commission grant in the amount of \$98,000 for the replacement of Bethany Road Bridge between Mason-Montgomery Road and Windemere Way. As part of the replacement, the City coordinated with Warren County to have the bridge extended to the north in preparation for the bike path project that is planned for next year. In order to extend the bridge, a portion of sewer force mains required relocation along with some necessary drainage improvements east of the bridge. Kurt stated the project is scheduled to start construction August 1, and will require a six-week closure of Bethany Road from Mason-Montgomery to SR-741, which will begin August 4. This ordinance provides authority to reimburse Warren County up to a total amount not to exceed \$178,888. The 2016 Budget included \$225,000 for this project.

A motion to suspend the rule and allow for adoption after the first reading was made by Councilmember Nelson, seconded by Councilmember Pelfrey. VOTE: ALL YEAS.

A motion to adopt Ordinance 2016-90 was made by Councilmember Chance, seconded by Vice Mayor Spaeth. VOTE: ALL YEAS.

**OLD AND NEW BUSINESS**

Council discussed Red, Rhythm and Boom. They liked that the event attracted a younger population, the size of the crowd, and great entertainment and activities. They expressed appreciation to Eric, Jennifer, and City staff for a very successful event. Eric Hansen explained the incident command structure, led by Jenna Hurley and Officer Chris Slone, was implemented for this event and helps keep staff skills well-honed for use in other situations. The City intentionally did not advertise regionally for this event, and may expand the promotion of future Red, Rhythm and Boom events. Council suggested the City consider entertainment for the Sunshine Concert series to attract a younger crowd. A suggestion to relocate some food and soft drink vendors closer to the beverage garden was received by some patrons of the event.

Kurt Seiler explained no cell towers could be installed in the right-of-way of Fairway Drive, even though it is a collector street, because the majority of Fairway Drive is in a residential area with a residential use and therefore would not meet the set-back requirement. On another topic, Perry said that he believes better communication regarding Council Committee Meetings is needed. If a committee is expected to spend most of the meeting time in executive session, notice should reflect that.


