Section 3. That this Resolution shall take effect and be in force from and after the earliest period allowed by law.

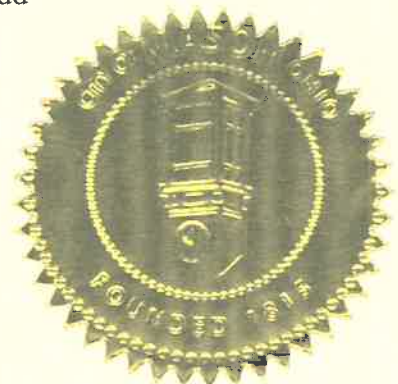

WHEREAS, Don Prince, by said service, has shown leadership, enthusiasm and energy and his contributions and dedication have had a profound impact on the well being of this community.


NOW THEREFORE, BE IT UNANIMOUSLY RESOLVED by the Council of the City of Mason, Ohio:
