ORDINANCE 2019 – 105

AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH CDW GOVERNMENT, INC. FOR THE PURCHASE OF AN UPGRADED STORAGE AREA NETWORK AND CAMERA STORAGE IN AND NOT TO EXCEED AMOUNT OF \$238,000 INCLUDING THE TRADE-IN OF AN OBSOLETE STORAGE AREA NETWORK

WHEREAS, the City wishes to purchase an upgraded storage area network and camera storage; and

WHEREAS, City staff has obtained quotes for this licensing; and

WHEREAS, CDW Government Inc., has provided the lowest quote with a price of \$83,000 for the purchase of the storage area network, which includes maintenance for the first three years of operation, with an annual maintenance cost of \$12,450 per year thereafter; and

WHEREAS, CDW Government Inc. has further offered a trade in credit in the amount of \$25,000 for the obsolete storage area network, bringing the total cost of the upgraded storage area network two \$58,000; and

WHEREAS, section 721.15 of the Ohio Revised Code provides that when the legislative authority determines that certain equipment is obsolete and no longer needed for a public purpose, in the municipality is in need of the same type of equipment, the purchase of the new equipment and training and of the obsolete equipment may be consummated in a single contract; and

WHEREAS, CDW Government Inc., has further provided the lowest quote with a price of \$158,000 for upgraded camera storage, which includes maintenance for the first three years of operation, with an annual maintenance cost of \$23,600 per year thereafter.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Mason, Ohio, seven members elected thereto concurring:

<u>Section 1.</u> That the existing storage area network owned by the City of Mason is hereby declared to be obsolete and no longer necessary for any public purpose.

<u>Section 2.</u> That it is in the best interest of the City of Mason to simultaneously purchase new upgraded storage area network simultaneously with the trade-in of the obsolete storage area network.

<u>Section 3.</u> That the City of Mason agrees that CDW Government, Inc. has provided the lowest quote for the desired upgraded storage area network and camera storage.

<u>Section 4.</u> That the City Manager is hereby authorized to enter into a contract with CDW Government, Inc. for said purchase.

Section 5. That the Finance Director is hereby authorized to pay CDW Government, Inc. an amount not to exceed \$238,000, representing the proposal amount with credit for a trade-in and an additional 10% allowance for a contingency, more fully detailed in the proposal attached hereto as Exhibit A, incorporated herein by reference.

<u>Section 6.</u> That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
