AtriCure Announces Multi-Year Project to Expand Global HQ In Mason, Ohio

State and local funding supports AtriCure's long-term plans for continued investment and jobs growth to fuel cardiovascular innovation.

MASON Ohio (Aug 15, 2024) — AtriCure, a global leader in surgical treatments for atrial fibrillation, post-operative pain management, and left atrial appendage management, announced plans today to further invest in the expansion of its global corporate headquarters campus on Innovation Way in Mason, Ohio. This multi-year phased investment will fuel AtriCure's research, development and manufacturing capabilities, building upon the critical mass of the City of Mason's MedTech and life sciences clusters.

AtriCure's expanded campus will house up to 120,000 square feet of new laboratory, R&D, office and advanced manufacturing space. The new construction includes expansion of the company's existing Mason Manufacturing Building with the construction of adjoining space. The expansion will allow for AtriCure's continued recruiting of talent from across the United States, bolstering the value proposition offered by AtriCure and similar companies in Mason and the region. The resulting project is the outcome of AtriCure's thoughtful long-term financial planning and years of continued partnership to bring the vision of an inclusive MedTech campus focused on delivering next-generation product development and manufacturing efficiency to reality. This is the fourth expansion to AtriCure's headquarters since it moved to Mason in 2015.

“With our history of delivering innovative solutions and advancing standards of care that improve lives around the globe, we are thrilled to continue our expansion in Mason, Ohio,” said Michael Carrel, AtriCure’s President and CEO. “This project underscores continued growth as we pursue our commitment to reaching more patients, reinforces our connection to the community, and reflects our strong and cooperative partnership with the City of Mason and the state of Ohio.”

“Innovative advancements and the desire to improve the lives of patients have fueled the growth and expansion of AtriCure’s Ohio-based global headquarters several times in the past decade,” JobsOhio President and CEO J.P. Nauseef. “As a strong partner for the state, AtriCure’s continued investment is creating jobs, attracting industry attention, and helping Ohio’s innovation ecosystem thrive.”

“The city has worked hard to secure this pivotal investment within our Biohub,” said Mason Mayor Diana Nelson. “As an anchor in Mason’s I-71 Innovation Corridor, AtriCure is paving the way for science growth and advancement to benefit the city, the region and the entire state.”

According to data compiled in early 2024 by the CBRE Research Team, approximately 20% of the Greater Cincinnati region’s biotech and life sciences companies are located in Mason. AtriCure’s expansion announcement further solidifies Mason’s strength as a hotspot for innovative scientific achievement in cardiology, genomics, mental health and medical device design and manufacturing. horizon

“With a decade under our belt, this project marks the next chapter for game-changing possibilities around new discovery, research and talent acquisition,” said Michele Blair, Mason’s economic development director. “Big thinking and partnership with the entire AtriCure leadership team has been key to this momentum.”

The City of Mason, REDI Cincinnati, state of Ohio, and JobsOhio all supported this major expansion with a series of incentives. The state of Ohio and the City of Mason today approved tax incentives to help catalyze the project and provide AtriCure operational flexibility. JobsOhio plans to provide assistance and will make that information public after a final agreement is executed.

“AtriCure’s selection of the Greater Cincinnati region as its corporate headquarters, announcing its fourth expansion today, underscores that our region is the premier Midwest destination for medical devices,” said Kimm Lauterbach, REDI Cincinnati president and CEO. “The City of Mason has established a hub to foster growth in the life sciences sector, significantly contributing to the region’s \$5.7 billion gross regional product, including advancements in medical devices, biotechnology, pharmaceuticals and health tech. Thank you to the City of Mason, JobsOhio, and the state of Ohio for their ongoing partnership.”

The City of Mason has attracted \$800 million in new private investment since the beginning of 2024. Companies that have announced new investments in Mason this year include Procter & Gamble, Cintas, VEGA, SixDigma, Haag-Streit, and InnoSign.
