

ORDINANCE 2017 – 28

ACCEPTING A BID AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH RUMPKE WASTE COLLECTION AND DISPOSAL SYSTEMS FOR THE WASTE COLLECTION AND DISPOSAL OF CERTAIN SOLID WASTES WITHIN THE CITY OF MASON AND AMENDING THE CODE OF ORDINANCES OF THE CITY OF MASON, OHIO SECTION 961.04 - CHARGES AND BILLING FOR RUBBISH AND WASTE COLLECTION

WHEREAS, bids were received for full service waste collection and disposal services; and

WHEREAS, Rumpke Waste Collection and Disposal Systems was the lowest and best bidder for waste collection and disposal for the period of May 1, 2017 through April 30, 2019 with three one-year renewal options for the unit prices shown on the bid summary, which is attached hereto as Exhibit “A”.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Mason, Ohio, six members thereto concurring:

Section 1. That the bid of Rumpke Waste Collection and Disposal Systems is hereby accepted as the lowest and best bid for full service waste collection and disposal services to the City for the period of May 1, 2017 through April 30, 2019 with three one-year renewal options for the unit prices shown on the bid summary, which is attached hereto as Exhibit “A”.

Section 2. That the City Manager is hereby authorized to enter into a two-year contract with three one-year renewal options with Rumpke Waste Collection and Disposal System for said services for the aforementioned period in accordance with the specifications set forth by the City.

Section 3. That the Finance Director is hereby authorized to pay Rumpke Waste Collection and Disposal Systems according to the terms of the contract.

Section 4. That the Code of the City of Mason, Ohio Section 961.04 Charges and Billing, is hereby amended as set forth in Exhibit “B” which is attached hereto.

Section 5. That this Ordinance shall be effective from and after the earliest period allowed by law.

961.04 CHARGES AND BILLING

(a) The following charges are hereby established for waste collection, in the City:

(1) For each single-family unit, the charge shall be:

	January 1, 2021	\$16.15
	January 1, 2022	\$16.64

(2) For each multi-family unit and for each trailer, the charge shall be:

Effective	May 1, 2011	\$14.35
	January 1, 2018	\$14.78
	January 1, 2019	\$15.22
	January 1, 2020	\$15.68
	January 1, 2021	\$16.15
	January 1, 2022	\$16.64

(3) For each industrial and commercial establishment, the charge shall be:

Effective	May 1, 2011	\$28.70
	January 1, 2018	\$29.56
	January 1, 2019	\$30.44
	January 1, 2020	\$31.36
	January 1, 2021	\$32.30
	January 1, 2022	\$33.27

If the total weekly collection from any such establishment is four cans or less, application may be made to the City for a reduction of charge to the current rate then in effect for single and multi-family residential customers. If the average weekly collection is more than ten cans, dumpsters are required.
