INSTRUCTIONS FOR FILING APPLICATION FOR EXTENSION OF TIME TO FILE MASON INCOME TAX RETURN

Upon written request of the taxpayer made on or before the date for filing the return, and for good cause shown, the Tax Administrator may extend the time for filing such return for a period of time not to exceed the last day of the sixth (6th) month of any extension requested of or granted by the Internal Revenue Service. No penalty shall be assessed in those cases in which the return is filed and the final tax paid within the period as extended, provided all other filing and payment requirements of the Income Tax Ordinance have been met (e.g. 90% of the tax due must be paid by January 31st or one month after the end of the fiscal year). Interest accrues on any tax due on the return from the date the return is originally due until paid. Please call 513-229-8535 with questions.

The City of Mason may deny a taxpayer's request for extension if the taxpayer:

- 1. fails to timely file the request;
- fails to file a copy of the federal extension request (if applicable);
- owes the City of Mason any delinquent income tax or any penalty, interest, assessment or other charge for the late payment or nonpayment of income tax;
- 4. has failed to file any required income tax return, report, or other related document for a prior tax period.

File duplicate copies of this application along with a self-addressed, stamped envelope with the City of Mason Tax Office, 6000 Mason-Montgomery Road, Mason, Ohio 45040. A copy of the Extension Request (Form ER) should be attached to the tax return when filed. The Mason Income Tax Return may be filed anytime on or before the extended due date.
