On July 2, 2021, Governor DeWine signed HB110, Biennial Budget bill.

HB110 creates a temporary rule beginning January 1, 2021 and ending January 1, 2022.

The temporary rule allows for refunds for those whose principal place of work has been changed due to Covid-19 beginning January 1, 2021.

This is for calendar year 2021 only and does not apply to 2020.
