1. I wish to enter and participate in Great Mason Chase;
2. I understand that Great Mason Chase is an arduous athletic event involving a race and biking, among other strenuous activities;
3. I am qualified, in good health, physically fit and in proper physical condition to participate in Great Mason Chase;
4. I understand my physical limitations and am sufficiently self-aware to stop physical activity before I become ill or injured;
5. I am aware that there is no set race course;
6. I am aware that all streets adjoining the race course are open to regular vehicular traffic during the race;
7. I am aware that no water stations exist on the course;
8. I am aware that no aid stations exist on the course other than at the start/finish area;
9. I will obey all traffic laws and regulations;
10. I understand that failing to adhere to the rules of Great Mason Chase could result in penalty or disqualification from the event;
11. I understand that by signing below, I am waiving my right to assert any claim or cause of action against Releasees in exchange for my participation in this event as described more fully above;
12. I understand that Great Mason Chase involves risks and dangers of serious bodily injury, including disability or death ("Risks"), that these risks may be caused by the action or inaction of myself or others, that there may be other risks and social and economic losses not known to me or foreseeable, and that I fully accept and assume all such risks and responsibility for losses, costs and damages I incur as a result of my participation in Great Mason Chase;
