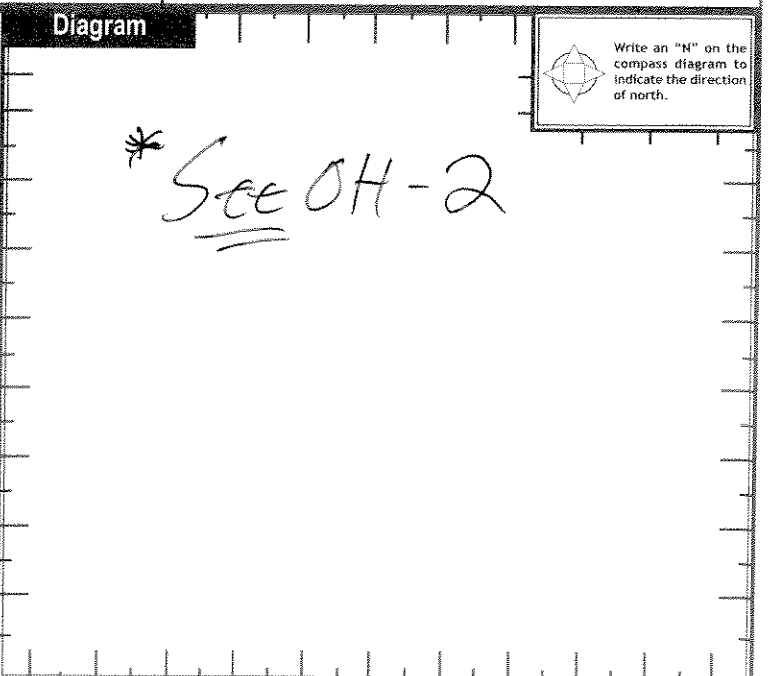

Narrative

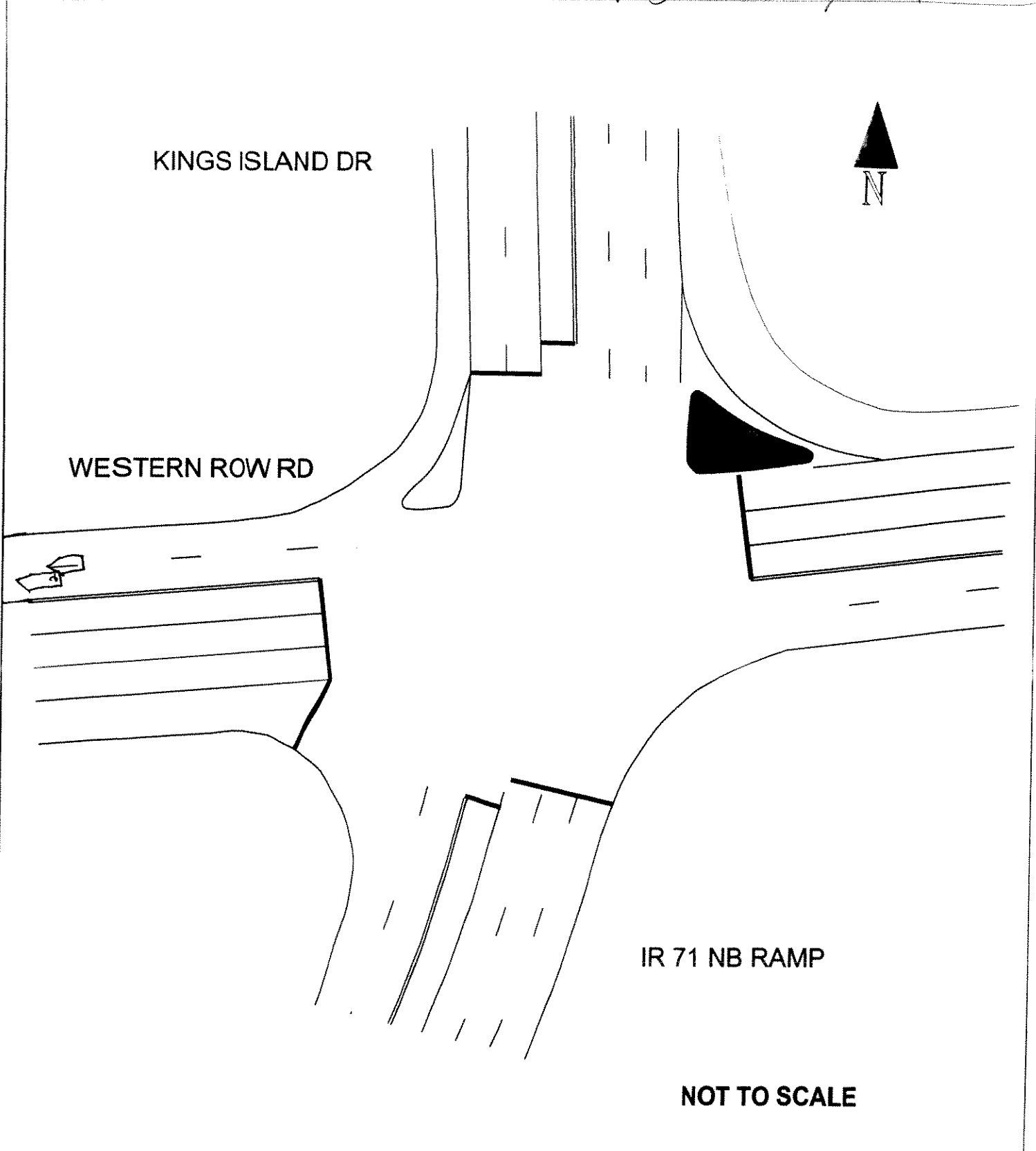
