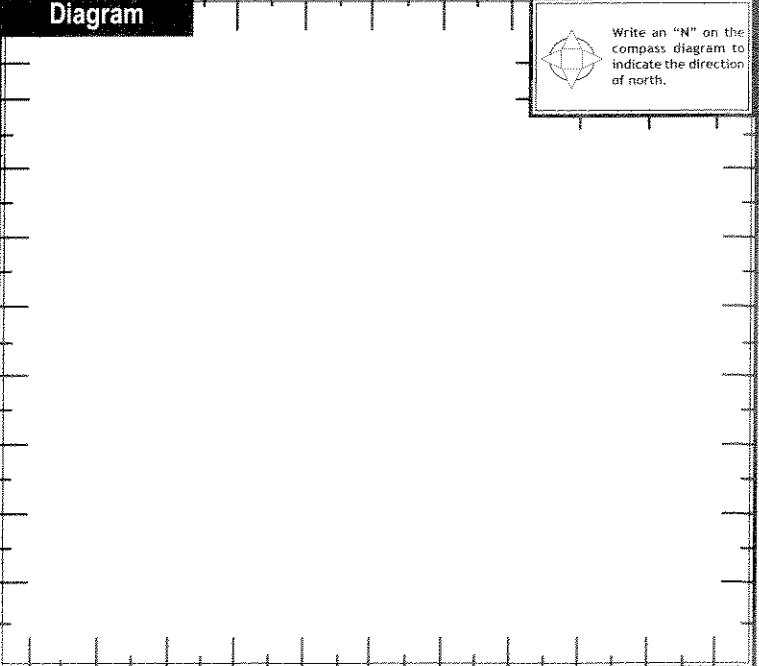

AFTER UNIT NO.1 WAS STRUCK, IT THEN STRUCK THE CURB OF THE TRAFFIC CIRCLE.

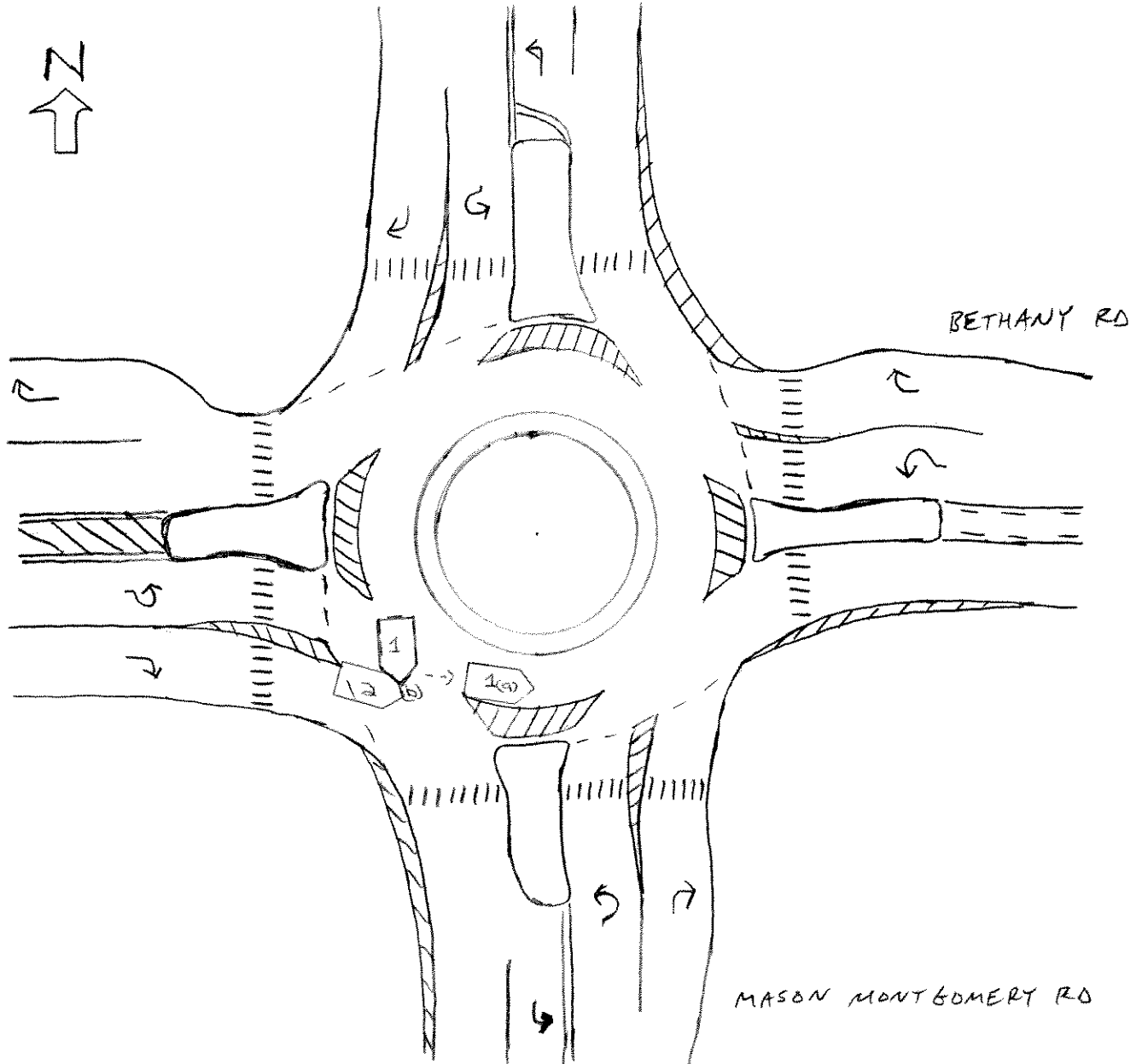

It was dark + rainy outside + I did not actually see the other motorist (I believe her lights were off). I did not see her before or after the accident until her hazard lights were turned on and she pulled behind me. I briefly spoke with her and told her to stay in her car with her son. ~~She~~ <sup>while</sup> I called the police. No witnesses stopped (that I am aware of).
