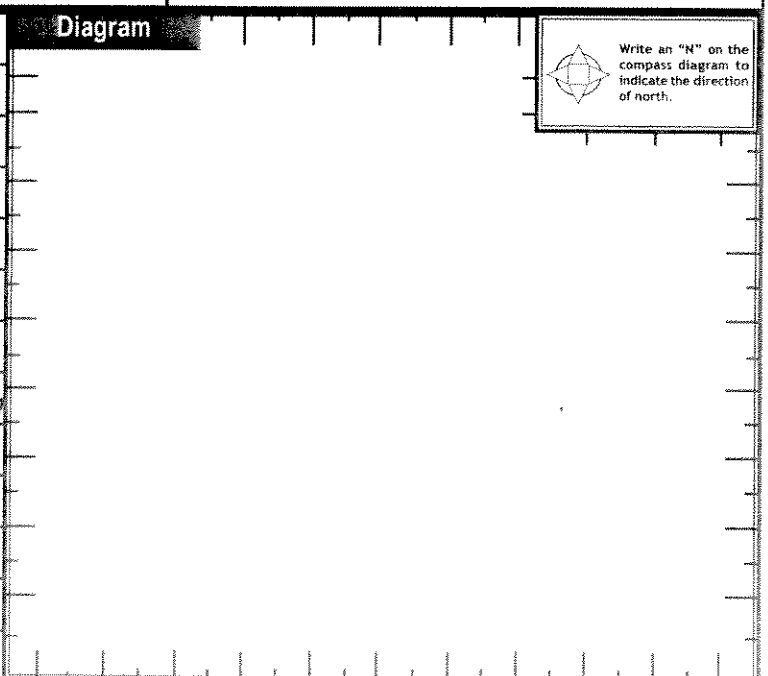

UNIT #1 FAILED TO STOP COMPLETELY AT STOP SIGN ON BETHANY ROAD (WEST) AT MASON MONTGOMERY ROAD. UNIT #1 STRUCK UNIT #2 IN THE LEFT FRONT. BOTH CARS WERE DISABLED FROM THE CRASH. UNIT #1'S SPEED WAS CALCULATED TO BE 21 MPH AT THE TIME OF IMPACT AFTER CRASH INVESTIGATION.

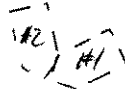
