

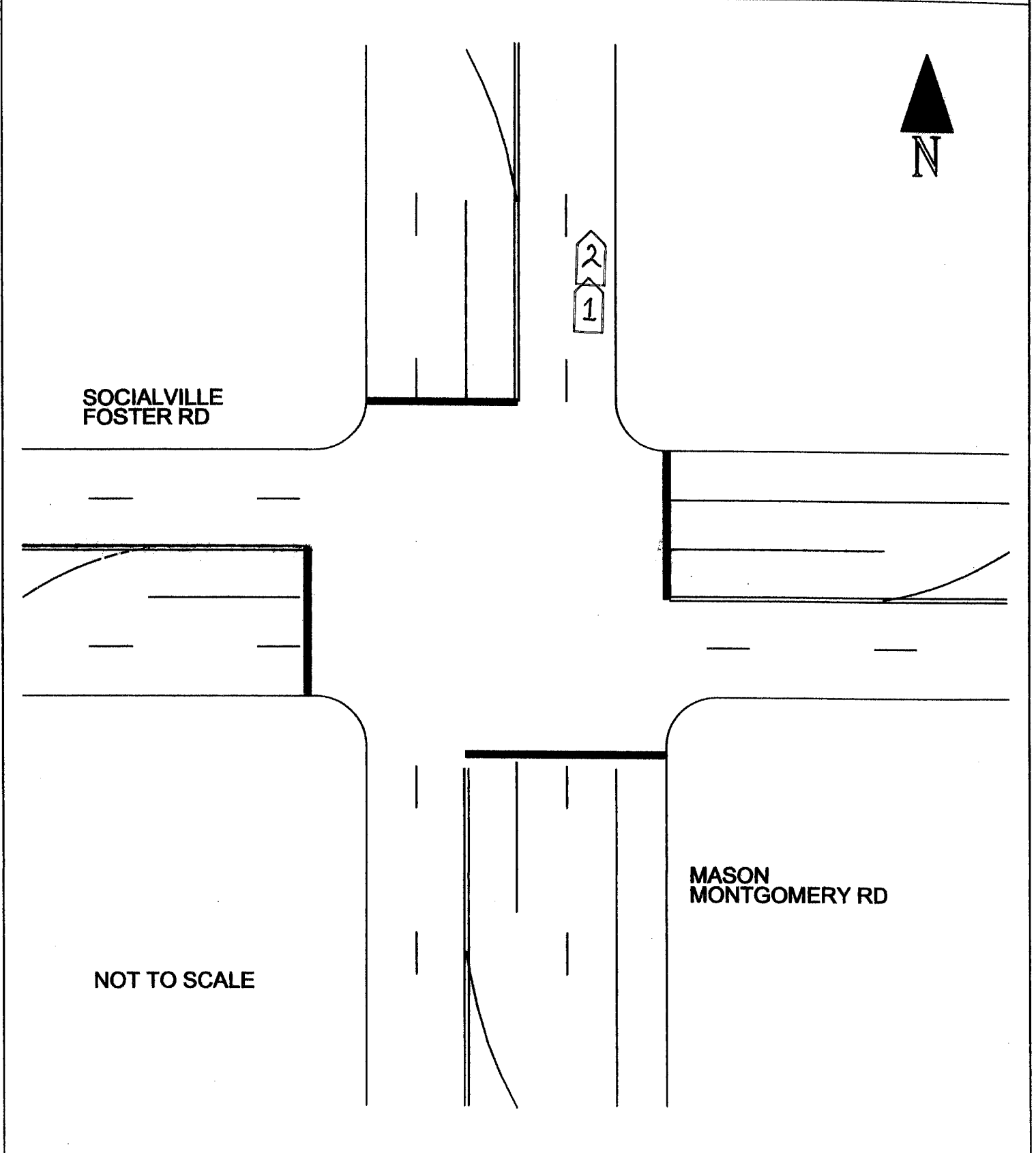

I was driving on Mason - Montgomery Rd. North bound pass Socialville - Fosters Rd. when traffic slowed down on the right lane (where we were) because a car was turning into the ODF gas station / White Blossom Square, I slowed down and then stopped and looked back on the rear view mirror and saw a black SUV behind me coming fast and not slowing down because the driver was looking down and not braking. I stepped on the break and waited for the impact. My son Alexander was with me in the passenger's seat. He also was wearing his seatbelt.
